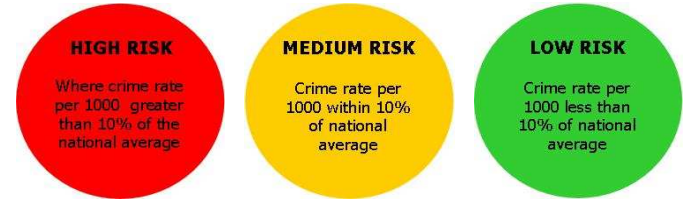
KEY TO LEVEL OF RISK OF CAR CRIME BY DISTRICT
